Arcadia and Encore are committed to producing sustainable, high-quality products that meet the stringent environmental and human health standards outlined in the BIFMA LEVEL® certification program. As part of this commitment, we actively evaluate and eliminate certain chemicals of concern from our products as follows.

Eliminated Chemicals

We have phased out and no longer utilize the following chemicals in the manufacture of our products:

- Perflourinated Compounds
- Polyvinyl Chloride (PVC)
- Antimicrobials
- Formaldehyde
- Flame Retardants

We ensure compliance with these chemical restrictions through:

- Supplier declarations
- Material Safety Data Sheets (MSDS)
- Third-party testing and certification where applicable, including SCS Indoor Advantage Gold certification for the majority of Arcadia and Encore products
- Ongoing product development and material innovation

Please note: Since fabrics are selected by the customer, Arcadia Chair Company's Declaration that seating products are free from chemicals of concern expressly excludes upholstery. Arcadia Chair Company will gladly assist in the fabric selection process, assuring that they are free of Flame Retardants, PFAS and PVC.
